# What is Accounting?

This guide from the ICAEW gives a detailed explanation of accountancy job roles. You should read this guide before applying to any Accounting and Finance course to gain some insight into the career and see if it really is the right choice for you. It is really important to know that you do not need to study accounting at university in order to be an accountant or to pursue a career in finance. The main thing that will set you up in either career is simply getting a good degree from a good university, in any subject.

## 1. Course links

Below are links to the top courses for this subject in the UK (according to <u>The Complete University Guide</u>). You should note that Cambridge University and Oxford University do not offer this course but a number of other prestigious Universities such as Queen's Belfast, LSE (London School of Economics), Warwick, Durham etc offer this course (although outside the top 5 of The Complete University Guide listing). Although they are not at the top of these rankings for this particular course, in general a degree from these universities would still be considered more 'prestigious' than those from some of the other unis in the top 5 here.

# 2. Entrance requirements

Here are the grades that the university suggests you need to get in to that course, and the likely offer that they will give you.

Glasgow: AAA – ABB
Strathclyde: AAA

Leeds: AAA
Aberdeen: BBB
Bath: AAA or A\*AB

# 3. Recommended A-levels

Different universities may differ as to what A-levels they ask you for. Some might list one subject as 'essential', while another might list the same subject as just 'helpful', so make sure to check out the course page (under Section 1 of this document, or on the university website) to be sure what your chosen university expects!

- 1. Glasgow: A-level Mathematics and GCSE English Grade B
- 2. Strathclyde: A-level Mathematics and GCSE English ( or an essay based course) Grade B
- Leeds: A-level Mathematics and GCSE English Grade B
- 4. Aberdeen: A-level Mathematics
- 5. Bath: A-level Mathematics

However, please note that you do not actually need Maths A-level to be an accountant, if you train after having done a different degree. Nevertheless, accountancy is a very numbers-heavy job, and you probably wouldn't enjoy it if you don't also like maths! You definitely do need to be good with numbers!

## **Degree Apprenticeships**

You might also consider applying for a degree apprenticeship.

Degree apprenticeships are a new type of programme offered by some universities. Students can achieve a full bachelor's or master's degree as part of their apprenticeship.

These programmes are being developed by employers, universities, and professional bodies working in partnership.

Degree apprenticeships combine working with studying part-time at a university. Apprentices are employed throughout the programme, and spend part of their time at university and the rest with their employer. This can be on a day-to-day basis or in blocks of time, depending on the programme and requirements of the employer.

They can take between three to six years to complete, depending on the course level.

#### **Joint Honour Degrees**

You may want to combine your study of finance with another course. There are two ways to do this:

#### "And" degrees

It is possible to combine two subjects at Honours level, typically 50% in each subject, such as English and Economics.

#### "With" degrees

You can take some Honours degrees with a major, for example: Biology with Arabic. "With" degrees allow the majority of modules to be taken in one specialist subject (major) alongside another minor subject in the final two years.
